The City of Bradenton City Council met in the City Hall Council Chamber, 101 Old Main Street, Bradenton, Florida, at 5:01 p.m. on Wednesday, September 18, 2019.

Mayor Wayne Poston opened the meeting at 5:01 p.m. and turned it over to Carl Callahan, City Administrator/Economic Development Director.

Mr. Callahan reiterated the budget that was advertised on September 14, 2019 covers the needs for the City of Bradenton and added the increase approved at the September 11, 2019 City Council Meeting associated with Water/Sewer/Reclaimed Water, Storm Water and Solid Waste rates are also included.

- The name of the taxing authority: City of Bradenton
- The rolled-back rate: 5.5912
- The percent increase over the rolled back rate: 5.48%
- The millage rate to be levied: 5.8976
