The City of Bradenton City Council met in the City Hall Council Chamber, 101 Old Main Street, Bradenton, Florida, at 5:01 p.m. on Wednesday, September 9, 2020.

Present: Mayor Wayne Poston; Councilman Ward I Gene Gallo; Councilwoman Ward II Marianne Barnebey; Councilman Ward III Patrick Roff; Councilman Ward IV Bill Sanders; and Vice Mayor/Councilman Ward V Harold Byrd, Jr.

City Officials: Carl Callahan, City Administrator; Sharon Beauchamp, City Clerk & Treasurer; Charles Edwards, Fire Chief; Melanie Bevan, Police Chief; Jim McLellan, Public Works & Utilities Director; and Scott Rudacille, City Attorney.

Mayor Wayne Poston opened the meeting at 5:01 p.m. and turned it over to **Carl Callahan, City Administrator**. Mr. Callahan announced this meeting is the first part of the approval process for the millage rate and budget. Mr. Callahan then asked **Sharon Beauchamp, City Clerk & Treasurer** to read the statutory announcement of TRIM requirements for the record.

Ms. Beauchamp officially read in to the record:

- The name of the taxing authority: City of Bradenton
- The rolled-back rate: 5.6834
- The percent increase over the rolled back rate: 3.77%
- The millage rate to be levied: 5.8976
